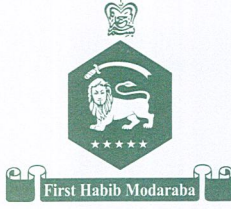

Further to our notice of book closure of **FIRST HABIB MODARABA** (the "*Modaraba*" - "*FHM*") vide our letter FHM/PSX/38776/2024 dated April 17, 2024 and pursuant to the PSX notice no. PSX/N-366 for suspension of trading in the certificates of FHM, we hereby convey the following information:

This is to inform you that the revised certificates of FHM after consolidation of face value i.e., twice of the closing price of its certificate on the last day of trading April 24, 2024, have been credited by CDC in CDS system after determining final entitlements. Therefore, trading of certificates has been resumed from May 06, 2024, as per the above referred earlier PSX notification.

Furthermore, the same shall be published in daily "Business Recorder" (*English*) and daily "Nawa-i-Waqt" (*Urdu*) newspapers for circulation in Karachi, Lahore and Islamabad.
