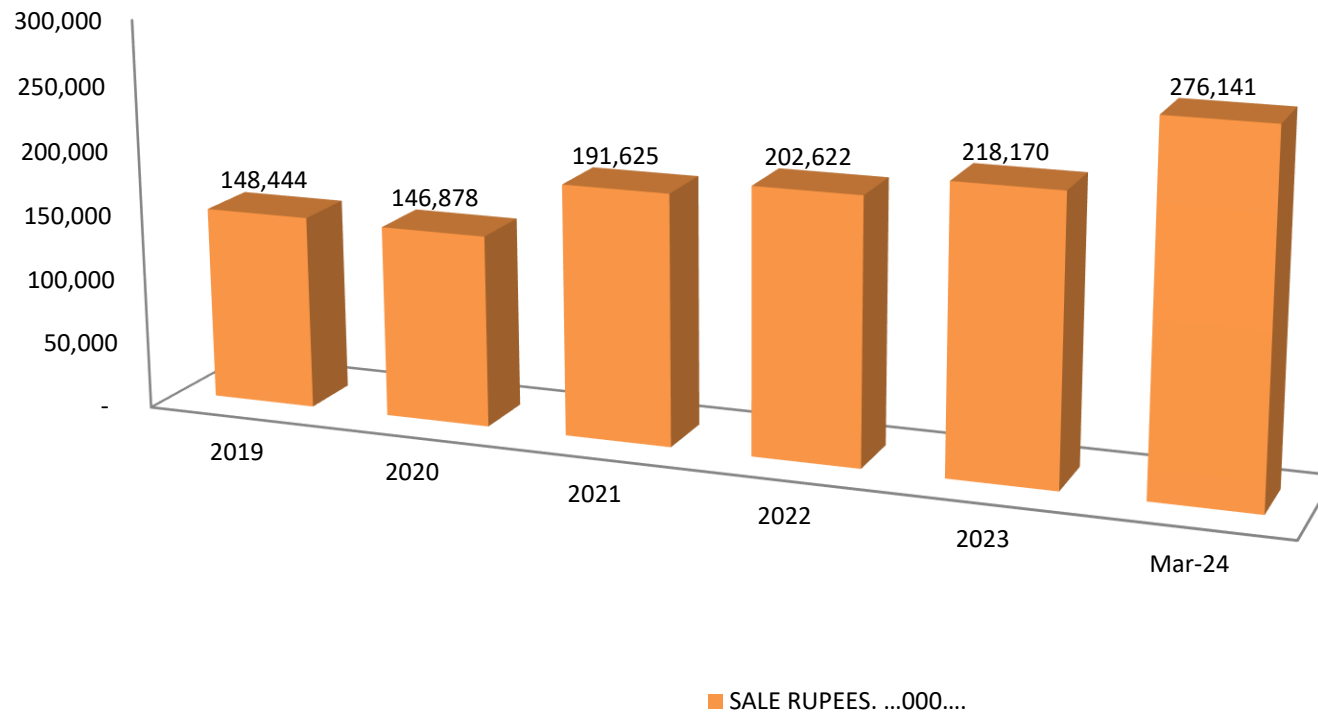
Research and Development

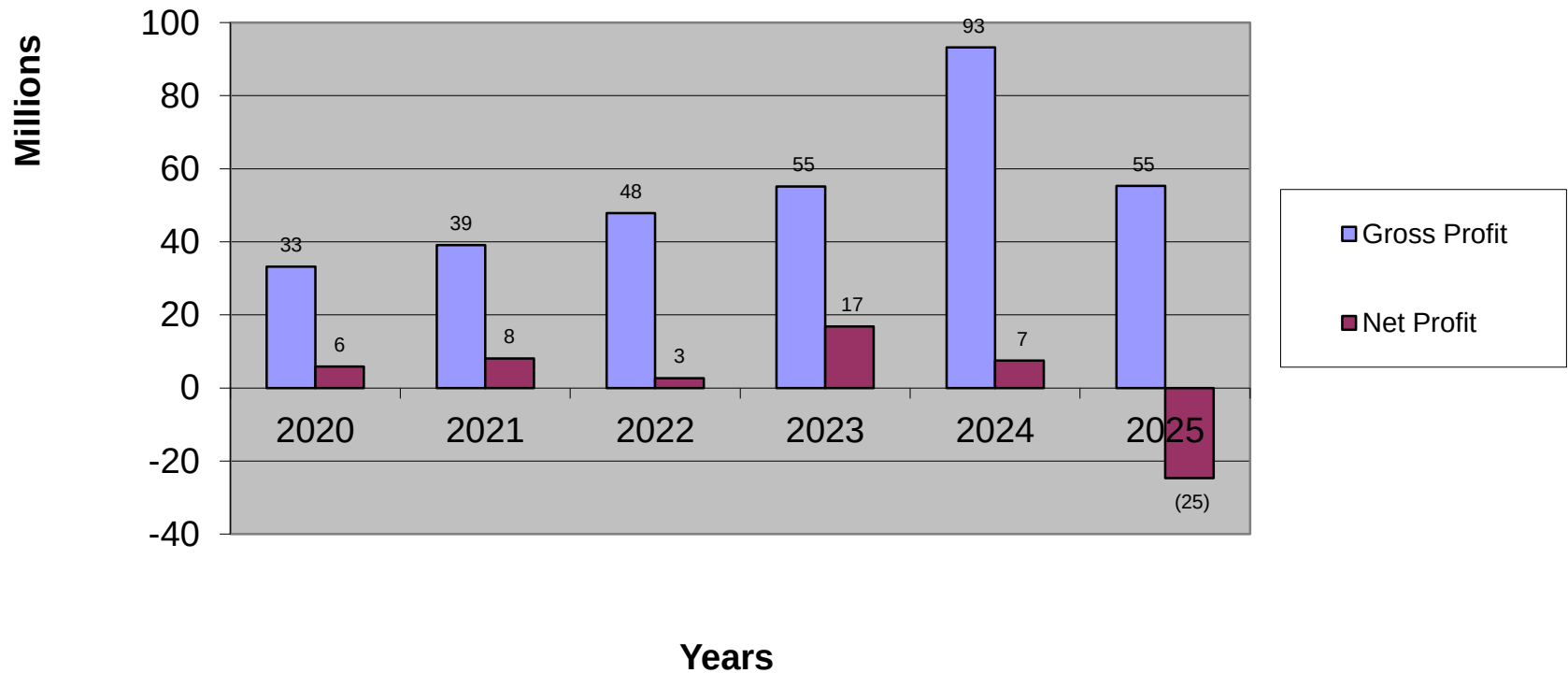
Financial Performance - Turnover



Gross Profit Vs. Net Profit



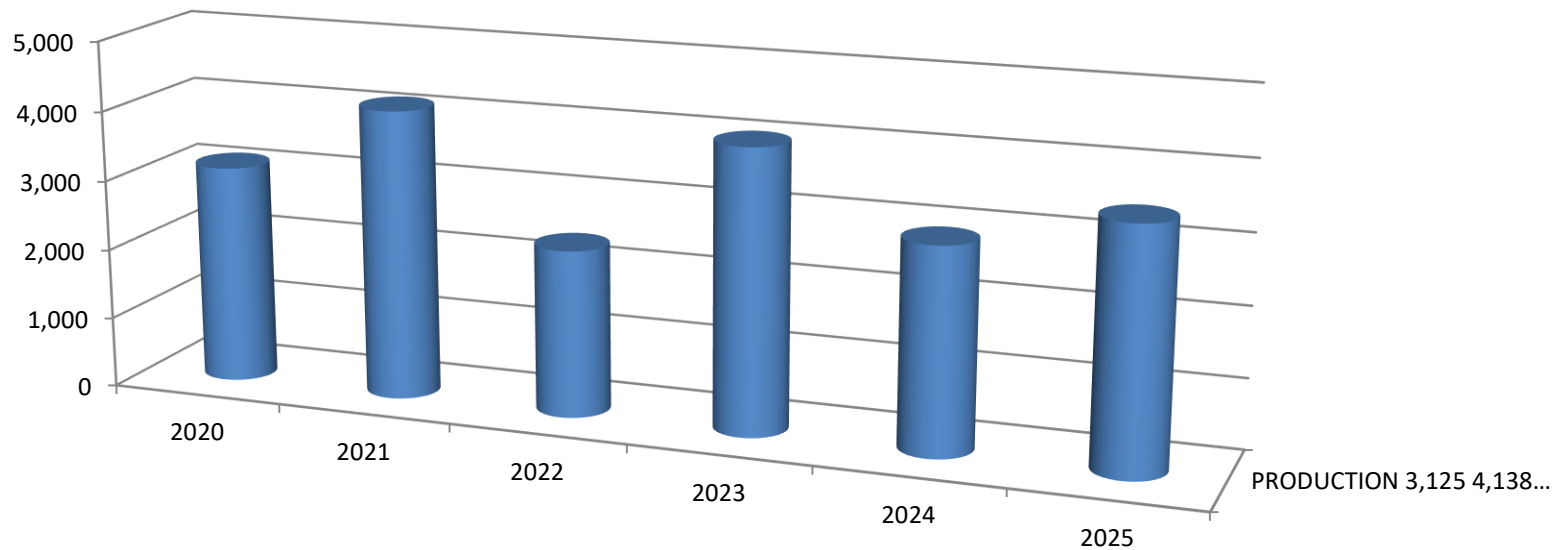
Gross Profit vs Net Profit
