In accordance with Section 96 of the Securities Act, 2015 and Clause 5.6.1(a) of PSX Regulations, we wish to inform you of the following:

The National Tariff Commission (NTC) has issued its decision on the Sunset Review of anti-dumping duties applicable to dumped imports of aluminium beverage cans of 250 ml to 300 ml originating in and/or exported from Jordan, Sri Lanka and the United Arab Emirates. The public notice of this decision was published in Daily Dunya and Daily Express Tribune on December 11, 2025 (copy enclosed).

NTC has concluded that the likelihood of continued dumping and material injury to the domestic industry remains if the current duties are removed. Based on this determination, NTC has extended the definitive anti-dumping duties for a further period of three years, effective February 19, 2025, at the following rates:

- Sri Lanka – Ceylon Beverage Cans: 23.24 percent
- Sri Lanka – All other exporters/foreign producers: 23.24 percent
- Jordan – All exporters/foreign producers: 26.54 percent
- United Arab Emirates – All exporters/foreign producers: 22.06 percent

You are requested to inform the TRE Certificate Holders of the Exchange accordingly.

NATIONAL TARIFF COMMISSION

Notice of Conclusion of Sunset Review of Anti-Dumping Duties Imposed on Dumped Imports of Aluminium Beverage Cans into Pakistan Originating in and/or Exported from Jordan, Sri Lanka and United Arab Emirates

The National Tariff Commission (the "Commission") under Section 58 of the Anti-Dumping Duties Act, 2015 (the "Act") and Chapter VI of Anti-Dumping Duties Rules, 2022 (the "Rules") has conducted a Review ("Sunset Review") of anti-Dumping duties imposed on dumped imports of Aluminium Beverage Cans of capacities 250 ml to 300 ml ("Aluminium Beverage Cans") into Pakistan originating in and/or exported from Jordan, Sri Lanka and United Arab Emirates (the "Exporting Countries"). The Sunset Review was initiated on February 08, 2024 upon receipt of an application under Section 58(3) of the Act from M/s Pakistan Aluminium Beverage Cans Limited, Faisalabad (the "Applicant"), is domestic producer of Aluminium Beverage Cans. The Commission had imposed anti-dumping duties ranging from 22.06 percent to 26.54 percent with effect from December 30, 2021 to February 19, 2025 on Aluminium Beverage Cans imported from the Exporting Countries.

In accordance with provisions of the Act and Rules, the Commission has conducted and concluded the Sunset Review as follows:

Product under Review: The product under Review is Aluminium Beverage Cans of capacities 250 ml to 300 ml ("Aluminium Beverage Cans"), originating in and/or exported from the Exporting Countries to Pakistan (the "product under Review"). The said product is classified under Pakistan Customs Tariff Heading No.7612.9030. The product under review is used for packaging of beverages.

Period of Review (POR): The Sunset Review has been conducted on the basis of information for three years i.e. from January 01, 2022, to December 31, 2024.

Likelihood of Continuation of Dumping of Product Under Review from the Exporting Countries: Based on the review investigation, the Commission has determined that there is likelihood of recurrence and/or continuation of dumping of the product under review from the Exporting Countries if anti-dumping duties imposed on dumped imports of product under review are terminated.

Likely Continuation and Recurrence of Injury to the Domestic Industry: Likelihood of continuation and/or recurrence of injury to the domestic industry has been determined by the Commission in accordance with Section 58(3) of the Act and Chapter VI of the Rules. The Commission has determined that, in case the anti-dumping duties imposed on dumped imports of the product under review from the Exporting Countries are terminated, the domestic industry would be likely to suffer material injury on account of increase in volume of dumped imports, price undercutting, price depression, price suppression, decline in production, capacity utilization, sales and market share; and negative effect on profits, inventories, return on investment, employment, cashflows, productivity and growth of the domestic industry.

Continuation of Definitive Anti-dumping Duties: In view of the determination of likely continuation of dumping of the product under review from the Exporting Countries and likely material injury to the domestic industry, there is a need to continue imposition of definitive anti-dumping duties on dumped imports of the product under review from the Exporting Countries. Thus, Commission has decided to continue anti-dumping duties on dumped imports of Aluminium Beverage Cans from the Exporting Countries for a further period of three years effective from February 19, 2025 at the following rates.

However, in accordance with Section 51(1) (ea) of the Act, definitive anti-dumping duty will not be levied on imports of the Aluminium Beverage Cans that are used as inputs in products destined solely for exports or for use in the foreign grant-in-aid projects and are covered under any scheme exempting customs duties for exports or foreign grant-in-aid projects under the Customs Act, 1969 (IV of 1969).

The antidumping duties shall take the form of ad valorem duty. Release of the dumped imports of the product under review for free circulation in Pakistan shall be subject to imposition of such antidumping duties.

The definitive anti-dumping duties would be collected in the same manner as customs duty is collected under the Customs Act, 1969 (IV of 1969) and would be deposited in National Tariff Commission's Non-lapsable PLD Account No.187 maintained under the Head G-11217, PLAWith Federal Treasury Office Islamabad.
