

- The battle for 78k continued with the KSE-100 making HoD @ 77,874
- 58 shares rose while 40 fell with MARI PA (+10.0%), OGDC PA (+7.29%) and PPL PA (+3.15%) the biggest contributors to index gains
- MARI announced FY24 EPS: 579.36, +38% YoY, DPS: 232 and 8 Bonus Shares for 1 held (800%). The result were above expectations and pushed price to new all time highs.
- A satellite imagery project carried out by Norwegian geospatial analysis estimates 10-15GW of new solar installation in Pakistan in 2024, making it the sixth largest market in the world. Pakistan's imports of solar products vastly exceed official statistics for installation, and are growing rapidly.
- Price action to leading stocks AIRLINK PA (+8.26%), FFBL PA (+7.08%) as well as momentum in EnP stocks post MARI PA earnings, are indicative of 78k being regained to set up fresh long entries next week
